TERMS AND CONDITIONS FOR CREDIT CARD PAYMENTS

1. General

- a. These terms and conditions apply to all credit card payments made (whether online, by telephone, or in any other manner) to Worldwide Logistic Partners, Inc.
- b. By making a credit card payment to Worldwide Logistic Partners, Inc., you accept these terms and conditions.
- c. Worldwide Logistic Partners, Inc. may amend these terms and conditions at any time without notice.

2. Definitions

- a. "Worldwide Logistic Partners, Inc.", "we", or "us" refers collectively to Worldwide Logistic Partners, Inc.
- b. "You" means you, the customer and cardholder.
- c. "Service" means any service provided by Worldwide Logistic Partners, Inc.
- d. "Credit Cards" includes both credit cards and debit cards.

3. Authorization

By providing your card information:

- a. You are stating that you are an authorized user of the credit card and that the associated information entered (account holder name, account number, billing address, etc.) is accurate.
- b. You authorize Worldwide Logistic Partners, Inc. to charge the amount you have requested including the service fee to your credit card.

4. Charges

- a. For each transaction, in addition to the charge you have authorized, your credit card issuer and network may assess their customary transaction or handling charge, if any.
- b. If a charge is declined or reversed by the credit card issuer or network, you agree to pay us a service charge and to reimburse us for all reasonable costs of collection. Your credit card issuer may also assess its customary charge for such transactions.

5. Dishonored Requests for Payments

- a. If your credit card issuer or network does not honor a payment transaction, then we have the right to charge the amount of any such transaction to your account or to collect the amount from you.
- b. If your credit card issuer or network does not honor a payment transaction, we may terminate any or all Service.

6. Confirmation of Payment

- a. By signing the Credit Card Authorization Form, you are consenting to receive a confirmation of this payment electronically to the email address you have provided to us.
